COMMERCE COMMISSION DECREE 2010
(DECREE NO. 49 OF 2010)

**Commerce (Price Control) (Foodstuffs)
(Amendment) (No. 3) Order 2011**

In exercise of the powers conferred upon me and on the recommendation of the Commission in accordance with Section 39 of the Commerce Commission Decree 2010 (Decree No. 49), I hereby declare the following—

Citation and commencement

1.—(1) This Order may be cited as the Commerce (Price Control) (Foodstuffs) (Amendment) (No. 3) Order 2011 and comes into force on 1st August 2011.

(2) The Counter-Inflation (Price Control) (Foodstuffs) (No. 7) (Amendment) (No. 4) Order 2009 is in this Order referred to as the 'Principal Order'.

10. Bakers and traders MUST ensure that the products and quantities specified in Schedules 1-8 must always be available at the retail end for the consumers to purchase. Provided that were specified quantities of the products in schedule 1-8 are not available, proportionate prices MUST be applied to all other quantities.
