## FINAL DETERMINATION FOR PRICES AT VUDA POINT MARINA

Date of Report: 23 December 2010

This determination follows the previous determination released on the 15 October 2010.

This determination has been undertaken to take into the effect the Value Added Tax (VAT) rate increase from 12.5 percent to 15.0 percent as was announced in the 2011 National Budget, which will be effective from 1 January 2011.
